What will happen if I am hired by Clubhouse Kids?
* Applicants are usually notified by phone if being offered a position.
* Applicants who are offered a position will be required to pass a substance abuse screening, fingerprint clearance, and submit a Medical Report prior to the start of work.
* Anyone hired must complete all required paperwork <u>prior</u> to the start of work.
* Anyone hired will need to participate in an orientation.
